ORDINANCE NO. 24-006

ORDINANCE FOR ADOPTION OF A DROUGHT CONTINGENCY PLAN

AN ORDINANCE OF THE CITY OF GILMER, TEXAS, RE-ADOPTING A DROUGHT CONTINGENCY PLAN: ESTABLISHING CRITERIA FOR THE INITIATION AND TERMINATION OF DROUGHT RESPONSE STAGES; **ESTABLISHING** RESTRICTIONS ON **CERTAIN** WATER USES: ESTABLISHING PENALTIES FOR THE VIOLATION OF AND PROVISIONS FOR ENFORCEMENT OF THESE RESTRICTIONS: ESTABLISHING **PROCEDURES** FOR **GRANTING** VARIANCES; AND **PROVIDING** SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the City of Gilmer, Texas recognizes that the amount of water available to the City and its water utility customers is limited and subject to depletion during periods of extended drought;

WHEREAS, the City recognizes that natural limitations due to drought conditions and other acts of God cannot guarantee an uninterrupted water supply for all purposes;

WHEREAS, Section 11.1272 of the Texas Water code and applicable rules of the Texas Natural Resource Conservation Commission requires all public water supply systems in Texas to prepare a drought contingency plan; and

WHEREAS, as authorized under law, and in the best interest of the citizens of Gilmer, Texas, the City Council deems it expedient and necessary to establish certain rules and policies for the orderly and efficient management of limited water supplies during drought and other water supply emergencies;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GILMER, TEXAS:

SECTION 1.

That the City of Gilmer, Texas Drought Contingency Plan attached hereto as Exhibit A and made part hereof for all purposes be, and the same is hereby adopted as the official policy of the City.

SECTION 2.

That all ordinances that are in conflict with the provisions of this ordinance be, and the same are hereby, repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3.

Should any paragraph, sentence, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof, other than the part so declared to be invalid, illegal or unconstitutional.

SECTION 4.

This ordinance shall take effect immediately from and after its passage, and the publication of the caption, as the law in such cases provides.

EXHIBIT A

DROUGHT CONTINGENCY PLAN FOR THE CITY OF GILMER, TEXAS

Section I: Declaration of Policy, Purpose and Intent

In order to conserve the available water supply and protect the integrity of water supply facilities, with particular regard for domestic water use, sanitation, and fire protection, and to protect and preserve public health, welfare, and safety and minimize the adverse impacts of water supply shortage or other water supply emergency conditions, the City of Gilmer hereby adopts the following regulations and restrictions on the delivery and consumption of water.

Water uses regulated or prohibited under this Drought Contingency Plan (the Plan) are considered to be non-essential and continuation of such uses during times of water shortage or other emergency water supply conditions are deemed to constitute a waste of water which subjects the offender(s) to penalties as defined in Section XI of this Plan.

Section II: Public Involvement

Opportunity for the public to provide input into the preparation of the Plan was provided by the City of Gilmer by means of scheduling and providing public notice of a public meeting to accept input on the Plan.

Section III: Public Education

The City of Gilmer will periodically provide the public with information about the Plan, including information about the conditions under which each stage of the Plan is to be initiated or terminated and the drought response measures to be implemented in each stage. This information will be provided by means of press releases.

Section IV: Coordination with Regional Water Planning Groups

The service area of the City of Gilmer is located within the Northeast Texas Regional Water Planning Group – Region D and City of Gilmer has provided a copy of this Plan to the Northeast Texas Regional Water Planning Group – Region D.

Section V: Authorization

The City Manager, or his/her designee, is hereby authorized and directed to implement the applicable provisions of the Plan upon determination that such implementation is necessary to protect public health, safety, and welfare. The City Manager, or his/her designee, shall have the authority to initiate or terminate drought or other water supply emergency response measures as described in this Plan.

Section VI: Application

The provisions of this Plan shall apply to all persons, customers, and property utilizing water provided by the City of Gilmer. The terms "person" and "customer" as used in the Plan include individuals, corporations, partnerships, associations, and all other legal entities.

Section VII: Definitions

For the purposes of this Plan, the following definitions shall apply:

<u>Aesthetic Water Use</u>: Water use for ornamental or decorative purposes such as fountains, reflecting pools, and water gardens.

<u>Commercial and Institutional Water Use</u>: Water use which is integral to the operations of commercial and non-profit establishments and governmental entities such as retail establishments, hotels and motels, restaurants and office buildings.

<u>Conservation</u>: Those practices, techniques, and technologies that reduce the consumption of water, reduce the loss of water of water, improve the efficiency in the use of water or increase the recycling and reuse of water so that a supply is conserved and made available for future or alternative uses.

<u>Customer:</u> Any person, company, or organization, using water supplied by the City of Gilmer.

<u>Domestic Water Use</u>: Water use for personal needs or for household or sanitary purposes such as drinking, bathing, heating, cooking, sanitation, or for cleaning a residence, business, industry, or institution.

Even Number Address: Street addresses, box numbers, or rural postal route numbers ending in 0, 2, 4, 6, or 8 and locations without addresses.

<u>Industrial Water Use:</u> The use of water in processes designed to convert materials of lower value into forms having greater usability and value.

<u>Landscape Irrigation Use:</u> Water used for the irrigation and maintenance of landscaped areas, whether publicly or privately owned, including residential and commercial lawns, gardens, golf courses, parks, and rights-of-way and medians.

Non-Essential Water Use: Water uses that are neither essential nor required for the protection of public health, safety, and welfare, including:

1. irrigation of landscape areas, including parks, athletic fields, and golf courses, except otherwise provided under this Plan;

- 2. use of water to wash any motor vehicle, motorbike, boat, trailer, airplane, or other vehicle;
- 3. use of water to wash down any sidewalks, walkways, driveways, parking lots, tennis courts, or other hard-surfaced areas;
- 4. use of water to wash down buildings or structures for purposes other than immediate fire protection;
- 5. flushing gutters or permitting water to run or accumulate in any gutter or street:
- 6. use of water to fill, refill, or add to any indoor or outdoor swimming pools or jacuzzi-type pools;
- 7. use of water in a fountain or pond for aesthetic or scenic purposes except where necessary to support aquatic life;
- 8. failure to repair a controllable leak(s) within a reasonable period after having been given notice directing the repair of such leak(s); and
- 9. use of water from hydrants for construction purposes or any other purposes other than fire fighting.

Odd Numbered Addresses: Street addresses, box numbers, or rural postal route numbers ending in 1, 3, 5, 7, or 9.

Section VIII: Triggering Criteria for Initiation and Termination of Drought Response Stages

The City Manager, or his/her designee, shall monitor water supply and/or demand conditions on a weekly basis and shall determine when conditions warrant initiation or termination of each stage of the Plan. Public notification of the initiation or termination of drought response stages shall be by means of publication in a newspaper of general circulation and local radio station.

The triggering criteria described below are based on a statistical analysis of the vulnerability of the surface and ground water sources under drought of record conditions.

1. Stage 1 – Mild Water Conditions

- a. When the surface supply available to the City of Gilmer is equal to or less than 60 percentage of storage.
- b. When the specific capacity of the City of Gilmer's well(s) are equal to or less than 90 percent of the well's original specific capacity.
- c. When total daily water demand equals or exceeds 1.5 million gallons for 10 consecutive days.

<u>Requirements for Initiation</u> - Customers shall be requested to voluntarily conserve water and adhere to the prescribed restrictions on certain water uses, defined in Section VII – Definitions.

<u>Requirements for Termination</u> – Stage 1 of the Plan may be rescinded when all of the conditions listed as triggering events have ceased to exist to a period of 7 consecutive days.

1. Stage 2 – Moderate Water Shortage Conditions

- a. When the surface supply available to the City of Gilmer is equal to or less than 50 percentage of storage.
- b. When the specific capacity of the City of Gilmer's well(s) are equal to or less than 85 percent of the well's original specific capacity.

<u>Requirements for Initiation</u> — Customers shall be required to comply with the requirements and restrictions on certain non-essential water uses provided in Section VII of the Plan.

<u>Requirements for Termination</u> – Stage 2 of the Plan may be rescinded when all of the conditions listed as triggering events have ceased to exist for a period of 7 consecutive days. Upon termination of Stage 2, Stage 1 becomes operative.

1. Stage 3 – Severe Water Shortage Conditions

- a. When the surface supply available to the City of Gilmer is equal to or less than 40 percentage of storage.
- b. When the specific capacity of the City of Gilmer's well(s) are equal to or less than 80 percent of the well's original specific capacity.

<u>Requirements for Initiation</u> — Customers shall be required to comply with the requirements and restrictions on certain non-essential water uses for Stage 3 of the Plan.

<u>Requirements for Termination</u> – Stage 3 of the Plan may be rescinded when all of the conditions listed as triggering events have ceased to exist for a period of 7 consecutive days. Upon termination of Stage 3, Stage 2 becomes operative.

1. Stage 4 – Critical Water Shortage Conditions

a. When the surface supply available to the City of Gilmer is equal to or less than 30 percentage of storage.

b. When the specific capacity of the City of Gilmer's well(s) are equal to or less than 75 percent of the well's original specific capacity.

<u>Requirements for Initiation</u> — Customers shall be required to comply with the requirements and restrictions on certain non-essential water uses for Stage 4 of the Plan.

<u>Requirements for Termination</u> – Stage 4 of the Plan may be rescinded when all of the conditions listed as triggering events have ceased to exist for a period of 7 consecutive days. Upon termination of Stage 4, Stage 3 becomes operative.

1. Stage 5 - Emergency Water Shortage Conditions

- a. Major water line breaks, or pump or system failures occur, which cause unprecedented loss of capability to provide water service; or
- b. Natural or man-made contamination of the water supply source(s).

<u>Requirements for Initiation</u> – Customers shall be required to comply with the requirements and restrictions for Stage 5 of this Plan when the City Manager, or his/her designee, determines that a water supply emergency exists based on:

<u>Requirements for Termination</u> — Stage 5 of the Plan may be rescinded when all of the conditions listed as triggering events have ceased to exist for a period of 1 consecutive day.

1. Water Rationing

- a. When the surface supply available to the City of Gilmer is equal to or less than 20 percentage of storage.
- b. When the specific capacity of the City of Gilmer's well(s) are equal to or less than 70 percent of the well's original specific capacity.

<u>Requirements for Initiation</u> – Customers shall be required to comply with the water allocation plan prescribed in Section X of the Plan and comply with the requirements and restrictions for Stage 5 of the Plan.

<u>Requirements for Termination</u> — Water rationing may be rescinded when all of the conditions listed as triggering events have ceased to exist for a period of 3 consecutive days.

Section IX: Drought Response Stages

The City Manager, or his/her designee, shall monitor water supply and/or demand conditions on a daily basis and, in accordance with the triggering criteria set forth in Section VIII of the Plan, shall determine that a mild, moderate, severe, critical, or emergency condition exists and shall implement the following actions upon publication of notice in a newspaper of general circulation:

Stage 1 – Mild Water Shortage Condition

Goal: Achieve a voluntary 10 percent reduction in total water use.

Supply Management Measures:

- 1. Reduced flushing of water main.
- 2. Reduction of wholesale customers' usage by 10 percent.
 - a. Water customers are requested to voluntarily limit the irrigation of landscaped areas to Sunday and Thursdays for customers with a street address ending in an even number (0, 2, 4, 6, or 8), and Saturdays and Wednesdays for water customers with a street address ending in an odd number (1, 3, 5, 7, or 9), and to irrigate landscapes only between the hours of 12:00 midnight and 10:00 AM and 8:00 PM to 12:00 midnight on designated watering days.
 - a. All operations of the City of Gilmer shall adhere to water use restrictions prescribed for Stage 2 of the Plan.
 - b. Water customers are requested to practice water conservation and to minimize or discontinue water use for non-essential purposes.

Stage 2 – Moderate Water Shortage Conditions

Goal: Achieve a 15 percent reduction in total water use.

Supply Management Measures:

- 1. Discontinue flushing of water mains.
- 2. Reduction of wholesale customers' usage by 15 percent.

<u>Water Use Restrictions</u>: Under threat of penalty for violation, the following water use restrictions shall apply to all persons:

1. Irrigation of landscaped areas with hose-end sprinklers or automatic irrigation systems shall be limited to Sundays and Thursdays for water customers with a street address ending in an even number (0, 2, 4, 6, or 8), and Saturdays and

Wednesdays for water customers with a street address ending in an odd number (1, 3, 5, 7, or 9), and irrigation of landscaped areas is further limited to the hours of 12:00 midnight until 10:00 AM and between 8:00 PM and 12:00 midnight on designated watering days. However, irrigation of landscaped areas is permitted at anytime if it is by means of a hand-held hose, a faucet filled bucket, or a watering can of five (5) gallons or less, or drip irrigation system.

- 2. Use of water to wash any motor vehicle, motorbike, boat, trailer, airplane, or other vehicle is prohibited except on designated water days between the hours of 12:00 midnight and 10:00 AM and between 8:00 PM and 12:00 midnight. Such washing, when allowed, shall be done with a hand-held bucket or a hand-held hose equipped with a positive shutoff nozzle for quick rinses. Vehicle washing may be done at any time on the immediate premises of a commercial car wash or commercial service station. Further, such washing may be exempted from these regulations if the health, safety, and welfare of the public is contingent upon frequent vehicle cleansing, such as garbage trucks and vehicles used to transport food and perishables.
- 3. Use of water to fill, refill, or add to any indoor or outdoor swimming pools, wading pools, or jacuzzi-type pools is prohibited except on designated watering days between the hours of 12:00 midnight and 10:00 AM and between 8:00 PM and 12:00 midnight.
- 4. Operation of any ornamental fountain or pond for aesthetic or scenic purposes is prohibited except where necessary to support aquatic life or where such fountains or ponds are equipped with a re-circulation system.
- 5. Use of water from hydrants shall be limited to fire fighting, related activities, or other activities necessary to maintain public health, safety, and welfare, except that use of water from designated fire hydrants for construction purposes may be allowed under special permit from the City of Gilmer.
- 6. Use of water for the irrigation of golf course greens, tees, and fairways is prohibited except on designated watering days between the hours of 12:00 midnight and 10:00 AM and between 8:00 PM and 12:00 midnight. However, if the golf course utilizes a water source other than that provided by the City of Gilmer, the facility shall not be subject to these regulations.
- 7. All restaurants are prohibited from serving water to its patrons except when requested.
- 8. The following uses of water are defined as non-essential and are prohibited:
 - a. wash down any sidewalks, walkways, driveways, parking lots, tennis courts, or other hard-surfaced areas;

- b. use of water to wash down buildings or structures for purposes other than immediate fire protection;
- c. use of water for dust control;
- d. flushing gutters or permitting water to run or accumulate in any gutter or street; and
- e. failure to repair a controllable leak(s) within a reasonable period after having been given notice directing the repair of such leak(s).

Stage 3 – Severe Water Shortage Conditions

Goal: Achieve a 25 percent reduction in total water use.

Supply Management Measures:

- 1. Discontinued flushing of water main.
- 2. Discontinued irrigation of public landscaped areas.
- 3. Reduction of wholesale customers' usage by 25%

<u>Water Use Restrictions:</u> All requirements of Stage 2 shall remain in effect during Stage 3 except:

- 1. Irrigation of landscaped areas shall be limited to designated watering days between the hours of 12:00 midnight and 10:00 AM and between 8:00 PM and 12:00 midnight and shall be by means of hand-held hoses, hand-held buckets, drip irrigation, or permanently installed automatic sprinkler system only. The use of hose-end sprinklers is prohibited at all times.
- 2. The watering of golf course tees is prohibited unless the golf course utilizes a water source other than that provided by the City of Gilmer.
- 3. The use of water for construction purposes from designated fire hydrants under special permit is to be discontinued.

Stage 4 - Critical Water Shortage Conditions

Goal: Achieve a 35 percent reduction in total water use.

Supply Management Measures:

- 1. Discontinued flushing of water mains.
- 2. Discontinued irrigation of public landscaped areas.
- 3. Reduction of wholesale customers' usage by 25%.

<u>Water Use Restrictions</u>: All requirements of Stage 2 and 3 shall remain in effect during Stage 4 except:

- 1. Irrigation of landscaped areas shall be limited to designated watering days between the hours of 6:00 AM and 10:00 AM and between 8:00 PM and 12:00 midnight and shall be by means of hand-held hoses, hand-held buckets, or drip irrigation only. The use of hose-end sprinklers or permanently installed automatic sprinkler systems are prohibited at all times.
- 2. Use of water to wash any motor vehicle, motorbike, boat, trailer, airplane, or other vehicle not occurring on the premises of a commercial car wash or a commercial service station and are not in the immediate interest of public health, safety, and welfare is prohibited. Further, such vehicle washing at commercial car washes and commercial service stations shall occur between the hours of 6:00 AM and 10:00 AM and between 6:00 PM and 10:00 PM.
- 3. The filling, refilling, or adding of water to swimming pools, wading pools, and jacuzzi-type pools is prohibited.
- 4. Operation of any ornamental fountain or pond for aesthetic or scenic purposes is prohibited except where necessary to support aquatic life or where such fountains or ponds are equipped with a re-circulation system.
- 5. No applications for new, additional, expanded, or increased-in-size water service connections, meters, service lines, pipeline extensions, mains, or water service facilities of any kind shall be allowed or approved.

Stage 5 - Emergency Water Shortage Conditions

Goal: Achieve a 50 percent reduction in total water use.

Supply Management Measures:

- 1. Discontinued flushing of water mains.
- 2. Discontinued irrigation of public landscaped areas.
- 3. Reduction of wholesale customers' usage by 35%.

<u>Water Use Restrictions:</u> All requirements of Stage 2, 3, and 4 shall remain in effect during Stage 5 except:

- 1. Irrigation of landscaped areas is absolutely prohibited.
- 2. Use of water to wash and motor vehicle, motorbike, boat, trailer, airplane, or other vehicle is absolutely prohibited.
- 3. City-wide burn ban will be in effect.

Section X: Water Rationing

In the event that water shortage conditions threaten public health, safety, and welfare, the City Manager is hereby authorized to ration water according to the following water allocation plan:

Single-Family Residential Customers

The allocation to residential water customers residing in a single-family dwelling shall be as follows:

Persons per Household	Gallons per Month
1 or 2	3,000
3 or 4	4,000
5 or 6	5,000
7 or 8	6,000
9 or 10	7,000
11 or more	8,000

"Household" means the residential premises served by the customer's meter, "Persons per Household" includes only those persons currently physically residing at the premises and expected to reside there for the entire billing period. It shall be assumed that a particular customer's household is comprised of two (2) persons unless the customer notifies the City of Gilmer of a greater number of persons per household on a form prescribed by the City Manager. The City Manager shall give his/her best effort to see that such forms are mailed, otherwise provided, or made available to every residential customer. If, however, a customer does not receive such a form, it shall be the customer's responsibility to go to the City of Gilmer offices to complete and sign the form claiming more than two (2) persons per household. New customers may claim more persons per household at the time of applying for water service on the form prescribed by the City Manager. When the number of persons per household increases so as to place the customer in a different category, the customer may notify the City Manager on such form and the change will be implemented in the next practicable billing period. If the number of persons in a household is reduced, the customer shall notify the City of Gilmer in writing within two (2) days. In prescribing the method for claiming more than two (2) persons per household, the City Manager shall adopt methods to insure the accuracy of the claim. Any person who knowingly, recklessly, or with criminal negligence falsely reports the number of persons in a household or fails to timely notify the City of Gilmer of a reduction in the number of persons in a household shall be fined not less than \$25.00. Residential water customers shall pay the following surcharges:

- for 1,000 gallons over allocation up through 1,000 gallons for each dwelling unit
- thereafter, for each additional 1,000 gallons over allocation up through a second 1,000 gallons for each dwelling unit.

- thereafter, for each additional 1,000 gallons over allocation up through a third 1,000 gallons for each dwelling unit.
- \$5 thereafter, for each additional 1,000 gallons over allocation.

Surcharges shall be cumulative.

Master-Metered Multi-Family Residential Customers

The allocation to a customer billed from a master meter which jointly measures water to multiple permanent residential dwelling units (e.g., apartments, mobile homes) shall be allocated 3,000 gallons per month for each dwelling unit. It shall be assumed that such a customer's meter serves two dwelling units unless the customer notifies the City of Gilmer of a greater number on a form prescribed by the City Manager. The City Manager shall give his/her best effort to see that such forms are mailed, otherwise provided, or made available to every such customer. If, however, a customer does not receive such a form, it shall be the customer's responsibility to go to the City of Gilmer offices to complete and sign the form claiming more than two (2) dwelling units. A dwelling unit may be claimed under the provision whether it is occupied or not. New customers may claim more dwelling units at the time of applying for water service on the form prescribed by the City Manager. If the number of dwelling units serviced by a master meter is reduced, the customer shall notify the City of Gilmer in writing within two (2) days. In prescribing the method for claiming more than two (2) dwelling units, the City Manager shall adopt methods to insure the accuracy of the claim. Any person who knowingly, recklessly, or with criminal negligence falsely reports the number of units served by a master meter or fails to timely notify the City of Gilmer of a reduction in the number of persons in a household shall be fined not less than \$25.00. Customers billed from a master meter under this provision shall pay the following monthly surcharges:

- for 1,000 gallons over allocation up through 1,000 gallons for each dwelling unit
- thereafter, for each additional 1,000 gallons over allocation up through a second 1,000 gallons for each dwelling unit.
- thereafter, for each additional 1,000 gallons over allocation up through a third 1,000 gallons for each dwelling unit.
- \$5 thereafter, for each additional 1,000 gallons over allocation.

Surcharges shall be cumulative.

Commercial Customers

A monthly water usage allocation shall be established by the City Manager, or his/her designee, for each nonresidential commercial customer other than an industrial customer who uses water for processing purposes. The nonresidential customer's allocation shall be approximately 75% of the customer's usage for the corresponding month's billing period for the previous 12 months. If the customer's billing history is shorter than 12 months, the monthly average for the period for which there is a record shall be used for any monthly period for which no history exists. Provided, however, a customer, 75% of whose monthly usage is less than 3,000 gallons, shall be allocated 3,000 gallons. The City Manager shall give his/her best effort to see that notice of each nonresidential customer's allocation is mailed to such customer. If, however, a customer does not receive such notice, it shall be the customer's responsibility to contact the City of Gilmer to determine the allocation. Upon request of the customer or at the initiative of the City Manager, the allocation may be reduced or increased if, (1) the designated period does not accurately reflect the customer's normal water usage, (2) one nonresidential customer agrees to transfer part of its allocation to another nonresidential customer, or (3) other objective evidence demonstrates that the designated allocation is inaccurate under present conditions. A customer may appeal an allocation established hereunder to the City Manager. Nonresidential commercial customers shall pay the following surcharges.

Customers whose allocation is 1,000 gallons through 10,000 gallons per month:

- \$2 per thousand gallons for the first 1,000 gallons over allocation.
- \$3 per thousand gallons for the second 1,000 gallons over allocation.
- \$4 per thousand gallons for the third 1,000 gallons over allocation.
- \$5 per thousand gallons for each additional 1,000 gallons over allocation.

Customers whose allocation is 10,000 gallons per month or more:

- times the block rate for each 1,000 gallons in excess of the allocation up through 5 percent above allocation.
- 2 times the block rate for each 1,000 gallons from 5 percent through 10 percent above allocation.
- 2 times the block rate for each 1,000 gallons from 10 percent through 15 percent above allocation
- times the block rate for each 1,000 gallons more than 15 percent above allocation.

The surcharges shall be cumulative. As used herein, "block rate" means the charge to a customer per 1,000 gallons at the regular water rate schedule at the level of the customer's allocation.

Industrial Customers

A monthly water usage allocation shall be established by the City Manager or his/her designee, for each industrial customer, which uses water for processing purposes. The industrial customer's allocation shall be approximately 90% of the customer's water usage baseline. Sixty (60) days after the initial imposition of the allocation for industrial customers, the industrial customer's allocation shall be further reduced to 85% of the customer's water usage baseline. The industrial customer's water usage baseline will be computed on the average water usage for the three (3) month period ending prior to the date of implementation of Stage 2 of the Plan. If the industrial water customer's billing history is shorter than 3 months, the monthly average for the period for which there is a record shall be used for any monthly period for which no billing history exists. The City Manager shall give his/her best effort to see that notice of each industrial customer's allocation is mailed to such customers. If, however, a customer does not receive such notice, it shall be the customer's responsibility to contact the City of Gilmer to determine the allocation, and the allocation shall be fully effective notwithstanding the lack of receipt of written notice. Upon request of the customer or at the initiative of the City Manager, the allocation may be reduced or increased, (1) if the designated period does not accurately reflect the customer's normal water usage because the customer had shut down a major processing unit for repair or overhaul during the period, (2) the customer has added or is in the process of adding significant additional processing capacity, (3) the customer has shut down or significantly reduced the production of a major processing unit, (4) the customer has previously implemented significant permanent water conservation measures such that the ability to further reduce usage is limited, (5) the customer agrees to transfer part of its allocation to another industrial customer, or (6) if other objective evidence demonstrates that the designated allocation is inaccurate under present conditions. A customer may appeal an allocation established hereunder to the City Manager. Industrial customers shall pay the following surcharge:

Customers whose allocation is 1,000 gallons through 20,000 gallons per month:

- \$2 per thousand gallons for the first 1,000 gallons over allocation.
- \$3 per thousand gallons for the second 1,000 gallons over allocation.
- \$4 per thousand gallons for the third 1,000 gallons over allocation.
- \$5 per thousand gallons for each additional 1,000 gallons over allocation.

Customers whose allocation is 20,000 gallons per month or more:

- times the block rate for each 1,000 gallons in excess of the allocation up through 5 percent above allocation.
- times the block rate for each 1,000 gallons from 5 percent through 10 percent above allocation.

- times the block rate for each 1,000 gallons from 10 percent through 15 percent above allocation
- times the block rate for each 1,000 gallons more than 15 percent above allocation.

Section XI: Enforcement

- 1. No person shall knowingly or intentionally allow the use of water from the City of Gilmer for residential, commercial, industrial, agricultural, governmental, or any other purpose, in a manner contrary to any provision of this Plan, or in an amount in excess of that permitted by the drought response stage in effect at the time pursuant to action taken by the City Manager or his/her designee, in accordance with provisions of this Plan.
- 2. Any person who violates this Plan is guilty of a misdemeanor and, upon conviction shall be punished by a fine of not less than Fifty Dollars (\$50.00) and not more than Two Hundred Fifty Dollars (\$250.00). Each day that one or more of the provisions in this Plan is violated shall constitute a separate offence. If a person is convicted of three or more distinct violations of this Plan, the City Manager shall, upon due notice to the customer, be authorized to discontinue water service to the premises where such violations occur. Services discontinued under such circumstances shall be restored only upon payment of a reconnection charge, hereby established at One Hundred Dollars (\$100.00), and any other costs incurred by the City of Gilmer in discontinuing service. In addition, suitable assurance must be given to the City Manager that the same action shall not be repeated while the Plan is in effect. Compliance with this Plan may also be sought through injunctive relief in the district court.
- 3. Any person, including a person not classified as a water customer of the City of Gilmer, in apparent control of the property where a violation occurs or originates shall be presumed to be the violator, and proof that the violation occurred on the person's property shall constitute a rebuttable presumption that the person in apparent control of the property committed the violation, but any such person shall have the right to show that he/she did not commit the violation. Parents shall be presumed to be responsible for violations of their minor children and proof that a violation, committed by a child, occurred on property within the parent's control shall constitute a rebuttable presumption that the parent committed the violation, but any such parent may be excused if he/she proves that he/she had previously directed the child not to use the water as it was used in violation of this Plan and that the parent could not have reasonably known of the violation.
- 4. Any employee of the City of Gilmer, police officer, or other City employee designated by the City Manager, may issue a citation to a person he/she reasonably believes to be in violation of this **Ordinance**. The citation shall be prepared in duplicate and shall contain the name and address of the alleged

violator, <u>if known</u>, the offence charged, and shall direct him/her to appear in the municipal court on the date shown on the citation and the date for which shall not be less than 3 days nor more than 5 days from the date the citation was issued. The alleged violator shall be served a copy of the citation. Service of the citation shall be complete upon delivery of the citation to the alleged violator, to an agent or employee of a violator, or to a person over 14 years of age who is a member of the violator's immediate family or is a resident at the violator's residence. The alleged violator shall appear in municipal court to enter a plea of guilty or not guilty for the violation of this Plan. If the alleged violator fails to appear in municipal court, a warrant for his/her arrest may be issued. A summons to appear may be issued in lieu of an arrest warrant. These cases shall be expedited and given preferential setting in municipal court before all other cases.

Section XII: Variances

The City Manager, or his/her designee, may, in writing, grant temporary variance for existing water uses otherwise prohibited under this Plan if it is determined that failure to grant such variance would cause an emergency condition adversely affecting the health, sanitation, or fire protection for the public or the person requesting such variance and if one or more of the following conditions are met:

- 1. Compliance with this Plan cannot be technically accomplished during the duration of the water supply shortage or other condition for which the Plan is in effect.
- 2. Alternative methods can be implemented which will achieve the same level of reduction in water use.

Persons requesting an exemption from the provisions of this Ordinance shall file a petition for variance with the City of Gilmer within 5 days after the Plan or a particular drought response stage has been invoked. All petitions for variances shall be reviewed by the City Manager, or his/her designee, and shall include the following:

- 1. Name and address of the petitioner(s).
- 2. Purpose of water use.
- 3. Specific provision(s) of the Plan from which the petitioner is requesting relief.
- 4. Detailed statement as to how the specific provision of the Plan adversely affects the petitioner or what damage or harm will occur to the petitioner or others if petitioner complies with the ordinance.
- 5. Description of the relief requested.
- 6. Period of time for which the variance is sought.
- 7. Alternative water use restrictions or other measures the petitioner is taking or proposes to take to meet the intent of this Plan and the compliance date.
- 8. Other pertinent information.

Variance granted by the City of Gilmer shall be subject to the following conditions, unless waived or modified by the City Manager or his/her designee:

- 1. Variances granted shall include a timetable for compliance.
- 2. Variances granted shall expire when the Plan is no longer in effect, unless the petitioner has failed to meet specified requirements.

No variance shall be retroactive or otherwise justify any violation of this Plan occurring prior to the issuance of the variance.

Section XIII: Severability

It is hereby declared to be the intention of the City of Gilmer that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this Plan shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Plan, since the same would not have been enacted by the City of Gilmer without the incorporation into this Plan of any such unconstitutional phrase, clause, sentence, paragraph, or section.
