## **DEFENSIVE DRIVING**

Defensive Driving is a method to keep a citation off of your driving record. Upon the timely completion of an approved driver's safety course and the return of the Certificate of Completion and a copy of your Driving Record (obtained from the Texas Department of Public Safety) to the court, the court dismisses your citation.

\*\*\*\*\*\*DO NOT TAKE DEFENSIVE DRIVING UNTIL IT HAS BEEN APPROVED BY THE COURT.\*\*\*\*\*\*

# Once you determine that you are eligible for Defensive Driving you must:

- Make a timely request to the court for defensive driving (within your appearance date) DO NOT TAKE DEFENSIVE DRIVING BEFORE APPROVAL FROM THE COURT\*\*
- 2. Present satisfactory proof of all the requirements (driver's license & insurance)
- 3. Pay the court cost plus applicable fee in full at the time of your request.

The court will then sign an order allowing you to complete defensive driving. You will have 90 days from the date of the court's order to complete your course and submit all paperwork (Certificate of Completion and Driving record).

If you do not turn in your Defensive Driving Certificate and your Driving Record to the court by the last day of your probation, you will be deemed to have failed the course. Extensions of time are not granted.

Mail: Court will process and mail everything back to you to the address that you provided. Please provide telephone number also.

In Person: You will be given all information on your appearance.

#### TO BE ELIGIBLE FOR DEFENSIVE DRIVING:

- 1. You must make the request for Defensive Driving either in writing or by appearing in person at the Municipal Court by the appearance date given on citation.
- 2. You must enter a plea of "guilty" or "no contest" and sign and submit a plea form.
- 3. You must pay the court costs of \$144.00 or \$169 (speeding in school zone) in full at the time you make the request. There are no extensions or payment plans for this payment.
- 4. You must show proof of valid automobile insurance with your name on the policy.
- 5. You must show proof of current valid Texas Driver's License.
- 6. You must not have taken a course for ticket dismissal within the 12 months preceding the date of your citation.

#### YOU ARE NOT ELIGIBLE IF:

- 1. You are accused of speeding 25 miles per hour or more than the posted limit.
- 2. Your violation occurred in a construction zone when workers were present.
- 3. You have a Commercial Driver's License.
- 4. You are accused of Fail to stop and give information/render aid.
- 5. You are accused of Passing a School Bus.
- 6. Leaving the scene of an accident (hit and run).
