PLEASE READ CAREFULLY

1. This letter is furnished as a courtesy to you by the Gilmer Municipal Court to assist you in making disposition of the charges filed against you by the Gilmer Police Department.
2. **IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOT CONTEST**, indicate in the proper space provided below. The fine for a NO CONTEST PLEA is the same as a plea of GUILTY. Either plea indicates that you agree to waive appearance before the Court of Trial.
3. You must refer to the schedule shown on the reverse of this sheet to determine the amount of your fine. The remittance must be paid by MONEY ORDER to the Gilmer Municipal Court. If your violation is not listed, contact the Municipal Court.
4. If you wish to attend a **DRIVING SAFETY COURSE** (for moving violations only) for the citation and you meet **ALL** the qualifications and requirements, you will be allowed to do so; **but you must contact the court first or check a plea box below and mail this sheet back along with requirements listed below.**
5. **Visit our website for information such as deferred disposition, payment plans, etc**

REQUIREMENTS FOR DRIVER SAFETY COURSE:

- a. Have a VALID TEXAS driver's license. (provide copy)
 - b. Have not taken a DSC course in the last 12 months and you are not currently taking a course for a citation filed in another court.
 - c. Are not charged with speeding 25 miles per hour or more over the posted speed limit.
 - d. Were not involved in hit and run accident, cited in an constuction zone with workers present, a CDL holder or cited for passing a school bus.
 - e. Will furnish the court with a copy of your liability insurance coverage
 - f. Will pay up front the administration fee and court cost of \$144.00 (or \$169 for speeding in School Zone) by money order. THIS IS DUE ON OR BEFORE YOUR APPEARANCE DATE ON CITATION.
6. **IF YOU FAIL TO RESPOND TO THIS CHARGE, A WARRANT WILL BE ISSUED FOR YOUR ARREST AND A HOLD MAY BE PLACED ON YOU DRIVER'S LICENSE.**
 7. **PHONE NUMBERS AND ADDRESSES ARE ON THE REVERSE SIDE OF THE SHEET.**
