MINUTES

1. CALL TO ORDER
INVOCATION
PLEDGE OF ALLEGIANCE

Mayor Tim Marshall called the meeting to order at 5:17 p.m. The invocation was led by Councilman William Hornsby and the pledge was led by Councilman Michael Chevalier.

2. CITIZEN COMMENTS

Mayor announced a GIF Economic Development meeting at Upshur Rural on December 05, 2018.

City Manager Greg Hutson addressed current sales tax as higher at this point than it was last fiscal year. We have seen an increase in Sales Tax for November, 2018 by 6.99%. Overall Sales Tax has increased 2.22% for the months of October and November. Councilman Brian Williams made a motion to approve consent agenda with a second by Councilman William Hornsby and a vote of 4/0 for approval.

Mayor Tim Marshall informed council of insurance proceeds for repairs to Fire Department VHF Antenna System. Cost for repairs is \$4,585.00 with a deductible of \$1,000.00.

City Manager Greg Hutson addressed council regarding proposed agreement between Bernie Smith and the City of Gilmer to provide plan review services for the new Gilmer ISD High School. The maximum plan review fee is \$2,134.00.

Based upon 46 miles of travel, time at site and inspection report preparation, site inspection fee would be \$390.00 for each inspection.
