1. CALL TO ORDER INVOCATION PLEDGE OF ALLEGIANCE

Councilman Brian Williams made a motion to approve consent agenda items with a second by Councilmember Teathel Hollis and a vote of 7/0 for approval.

4. CONSIDER AND ACT ON AUTHORIZING THE MAYOR TO APPROVE THE ELECTION CONTRACT BETWEEN THE CITY OF GILMER AND THE COUNTY OF UPSHUR FOR THE GENERAL ELECTION TO BE HELD NOVEMBER 3, 2020 (EMCLOSURE).

10. CONSIDER AND TAKE ACTION AUTHORIZING CITY MANAGER TO APPLY FOR FY 2020 CARES ACT FINANCIAL RELIEF FUNDING GRANT FROM TX DOT AVIATION (ENCLOSURE).

City Manager Greg Hutson addressed council stating that the Cares Act funding would be in the amount of \$30,000.00 and is designated for airport use.

Councilman Marty Jordan made a motion to authorize City Manager to apply for 2020 cares act from TXDOT Aviation with a second by Councilmember Teathel Hollis and a vote of 7/0 for approval.

11. CONSIDER DISCUSSION AND TAKE ACTION AUTHORIZING CURRENT SIGNATORIES ON CURRENT BANK ACCOUNTS FOR NEW COVID-19 BANK ACCOUNT. SIGNATORIES ARE MAYOR TIM MARSHALL, MAYOR PRO-TEM WILLIAM HORNSBY, CITY MANAGER GREG HUTSON, AND CITY SECRETARY MARIA CISNEROS (ENCLOSURE).

City Manager Greg Hutson addressed council and informed them that refunding the 2010 bond series with this refunding will save the City approximately \$538,880 over the term of the note through the year 2034.

City Attorney Mike Martin discussed donation of land from GIF to airport in exchange for the 20% city owned interest in Texasta property, City would receive adjoining acreage from GIF of 5.12 acres. GIF would pay for the survey of donated property.

Mayor Tim Marshall made a motion to accept donation of land from GIF in exchange for 20% city interest in Texasta property with a second by Councilmember Teathel Hollis and a vote of 7/0 for approval.
