1. CALL TO ORDER INVOCATION ROLL CALL

Mayor Tim Marshall called the meeting to order at 5:15 p.m. The invocation was led by Councilmember William Hornsby and Pledge of Allegiance was led by Mayor Tim Marshall.

2. CITIZEN COMMENT

Linsey Hitt with Credit Union of Texas addressed council regarding future fall festival that will take place in November 13th, 2021.

3. CONSIDER ADOPTION OF THE FOLLOWING PROCLAMATION:

a. NATIONAL DOMESTIC VIOLENCE AWARENESS MONTH" PROCLAMATION

Mayor Tim Marshall read the proclamation and presented it to Heather Miller, Megan Johnson, Sheri Wayt with the Women's Center of East Texas.

Councilmember William Hornsby made a motion to consent agenda items with a second by Councilmember Brian Williams and a vote of 4/0 for approval.

5. CONSIDER AND ACT UPON DECLARING DISTRICT 4 COUNCIL SEAT CURRENTLY HELD BY COUNCIL PERSON TEATHEL HOLLIS AS VACANT.

City Attorney Mike Martin informed Council regarding the vacancy for District 4. section 3.03 of the City Charter states a Councilmember or Mayor shall forfeit his/her office he or she: (e) fails to attend three (3) consecutive regular meetings of the Council. On January 26th, 2021 City Council meeting it was approved to excuse Councilmember Teathel Hollis from attending council meetings. City Manager Greg Hutson stated that it appears that Councilmember Teathel Hollis is unable to come back due to declining health.

Mayor Tim Marshall made a motion declaring district 4 council seat vacant with a second by Councilmember Brian Williams and a vote of 4/0 for approval

6. CONSIDER AND ACT UPON FILLING VACANT COUNCIL SEAT REPRESENTING COUNCIL DISTRICT 4:

a. Jasmine Cunningham

City Manager Greg Hutson addressed council and stated he had received two candidates, one was ineligible due to not living in the district and the other resides within district 4.

Councilmember Brian Williams made a motion to appoint Jasmine Cunningham for district 4 seat with a second by Councilmember Michael Chevalier and a vote of 4/0 for approval.

Councilmember Jasmine Cunningham took district 4 seat.

7. CITY SECRETARY WILL ADMINISTER OATH OF OFFICE TO APPOINTED CANDIDATE. City Secretary Maria Cisneros administered oath of Office to Councilmember Jasmine Cunningham.

8. CONSIDER AND DISCUSS ENTERPRISE FUND ADDITIONAL STIMULUS FUNDS RECEIVED FROM TDEM IN THE AMOUNT OF \$637,181.57.

City Manager Greg Hutson informed council we had recently received this amount and we will receive it again next September 2021.

9. CONSIDER AND DISCUSS CIVIC CENTER FUNDS RECEIVED FROM SBA IN THE AMOUNT OF \$38,559.60.

City Manager Greg Hutson praised Civic Center Director Lisa Long for getting all information needed to apply for this grant. Grant funds of \$38,559.60 will be deposited into general fund account.
