1. CALL TO ORDER INVOCATION ROLL CALL

Mayor Tim Marshall called the meeting to order at 5:16 p.m. The invocation was led by City Manager Greg Hutson and Pledge of Allegiance was led by Councilmember Marty Jordan.

2. CITIZEN COMMENT

Mayor Tim Marshall informed Council and audience of former Councilmember Teathel Hollis's passing. Mrs. Hollis represented District Four. Her funeral service will take place on Saturday, August 27, 2022.

Budget for this year includes increase of employee health insurance rate of 5.82%, employee pay adjustments for police department, fire department, public works, civic center to be close to market rate, and 5% cost of living employee raises for City Hall staff. There was an increase in property insurance 18%, workers compensation, and finally fuel cost. Mayor Tim Marshall closed public hearing at 5:35 p.m.
