III. Consent Agenda

Councilmember Jarom Tefteller walked in at 5:16 p.m.

IV. Items to Consider

1. Consider, discuss and take possible action to approving appointments to the Parks Advisory Board of seven (7) members.

Councilmember Michael Chevalier asked about letting public know if any one would like to be on the board, and not just renewing current members terms.

Councilmember Michael Chevalier made the motion to table item to a later meeting with a second by Councilmember Marty Jordan and a vote of 6/0 vote for approval.

2. Consider, discuss and take possible action to approve closure of Simpson Street from Hwy 154 to Jefferson Street for a Chili Cookoff event sponsored by Credit Union of Texas from Friday, February 24, 2023 at 6:00 p.m. until Sunday, February 26, 2023 at 10:00 a.m.

Richard Henson, 903 Developments Manager, stated that there are 11 total with 9 under construction and will be a total of 72 homes.

- 7. Consider, discuss and take possible action on the recommendation from Gilmer Parks Advisory Board to consider using Red River Recreation to construct the improvements at Abney Park.
 - David Barnes, Red River Construction, briefly explained to council his accomplishments in and near the Gilmer area, and how he always tries to use local vendors that are certified.
 - Councilmember Michael Chevalier stated the Mr. Barnes has worked with the Parks Advisory Board and the residents surrounding Abney Park and they picked out the design and colors for the new equipment.

8. Consider, discuss and take possible action to approve a Warrant Recall from March 1 – April 28, 2023 with waiving the Warrant Fee if payment arrangements are made.

City Manager Greg Hutson briefly explained to council how the Warrant Recall will work.

9. Consider, discuss and take possible action to pursue development of an application for 2023-2024 TXCDBG Grant with Traylor and Associates pertaining to Administrative Services.

Councilmember Jarom Tefteller asked what streets will be used by the grant because a lot of streets need repairs. City Manager Greg Hutson stated it hasn't been decided because we are in the beginning stages of the grant process. Could possibly be used for Montgomery Street since we have tried in the past for that same street.

Stan Hayes, Hayes Engineering, explained what TxCDBG is and how the point systems usually work.

Councilmember Marty Jordan made a motion to pursue development of an application for 2023-2025 TXCDBG Grant with Traylor and Associates pertaining to Administrative Services with a second by Councilmember Jarom Tefteller and a vote of 6/0 for approval.

10. Consider, discuss and take possible action on the bids for Kimway Circle Drainage Improvements accepting the lowest bid from CD Thomas Utilities of Gilmer, Texas.

Stan Hayes, Hayes Engineering, explained to the council the bidding process and the outcomes of the bids.

Councilmember Michael Chevalier made a motion to approve the lowest bid for Kimway Circle Drainage Improvements awarding the base bid and additional alternatives to CD Thomas Utilities of Gilmer, Texas in the amount of \$72,126.00 with a second by Mayor Pro-Tem Pete Herrmann and a vote of 5/0 approval with 1 abstained by Councilmember Jarom Teftteller.

11. Consider, discuss and take possible action on Ordinance 23-008 amending the City Budget for the City of Gilmer, Texas for the one-year period beginning October 1, 2022 and ending September 30, 2023 for Kimway Circle Draining Improvements in the amount of \$72,126.00.
