Mayor Pro-Tem Pete Herrmann made a motion to approve consent agenda items, with a second by Councilmember Jasmine Cunningham, and a vote of 6/0 for approval.

1. Consider, discuss, and take possible action to approve the Quarterly City Investment Report for period ending December 31, 2023.

City Manager Greg Hutson briefly explained the Investment Report.

- 2. Consider, discuss, and take possible action regarding the Risk it for Brisket event street closure from April 4 at 7:00 pm until Sunday, April 7, 2024 at 8:00 pm for the event on April 5-6. 2024.

Mayor Tim Marshall commented he is opposed to closing Hwy 154 because the proper signage is not placed. Councilmember Michael Chevalier made a comment that this is a big event similar to the Yamboree. Chris Moore, Live Gilmer, stated the road closures were made by their engineer and TxDot assigns for the signage.

Mr. Griffith's question was, if Kevin Honeycutt applies for a building permit, will it be approved or not so we can move forward with the project. City Attorney Mike Martin stated if they have their own engineer, then Kevin and their engineer would be liable with issues and not the city.
