Wendy Starkes, TxDOT, explained the Municipal Maintenance Agreement to the council and it is the same for all cities. Since working on the turnouts is considered maintenance, then the city is responsible for them. Ms. Starkes stated for good faith from TxDOT, they will do a one-time fix, and future maintenance will fall on the city.

Stan Hayes and Greg Hutson will get a list of streets together along with prioritizing them and submit the list to Wendy Starkes.
