Councilmember Jerry Webb made a motion to approve the closure of Titus, Buffalo and Trinity Streets for the Annual Yulefest Parade hosted by the Yulefest Committee on Saturday, December 7, 2024, from 5:00 P.M. – 7:00 P.M., with a second by Councilmember Marty Jordan, and a vote of 5/1 for approval.

2. Consider, discuss, and take possible action to approve the bid recommendation by Hayes Engineering for ARPA Project 2024 Tank Repairs and Maintenance to J & A Coatings, LLC for \$693,411, and all matters related thereto (Enclosure).

Stan Hayes from Hayes Engineering discussed the bid process and requirements for tanks repairs and the four bids received for the project.

Councilmember Jerry Webb made a motion to approve the bid recommendation by Hayes Engineering for ARPA Project 2024 Tank Repairs and Maintenance to J & A Coatings, LLC for \$693,411, with a second by Councilmember Marty Jordan, and a vote of 6/0 for approval.

3. Consider and discuss the Yamboree Park Project with an update from City Engineer, Stan Hayes, of Hayes Engineering and matters related thereto.

Stan Hayes from Hayes Engineering updated the council regarding the status of the park project and said that the electrical schematics are days away from completion. The first bid package

would be for the completion of the baseball fields, parking lots next to fields, and the dirt work for the soccer fields. The advertising for the bids would go out in January 2025 with the hopes of the baseball fields being completed before leagues start playing in May. Councilmember Jarom Tefteller had concerns about the proposed direction of the baseball fields and how the sun would be in the players' eyes. Stan Hayes said he could fix some of the issues and would come back with some changes.

City Manager Greg Hutson stated he spoke to Josh Bray at Sanitation Solutions and the increase was for the Dallas/Fort Worth area. Councilmember Jarom Tefteller said the proposed rate is still well above the BLS - CPI that was calculated as 2.06% from September 2023 to September 2024. The council agreed to pass on taking action to approve Ordinance No. 24-041 Amending the Monthly Charges for Sanitation Solutions and have asked for a representative from Sanitation Solutions to attend the next council meeting in January.

City Manager Greg Hutson explained the certificate and its impact to our financial standing within the bond market. He also thanked city employees for their hard work for the city to achieve the recognition.
