Mayor Tim Marshall called the meeting to order at 5:16 P.M. The invocation was led by Mayor Pro-Tem Pete Herrmann, and the Pledge of Allegiance was led by Councilmember Marty Jordan.

Councilmember Jerry Webb made a motion to approve consent agenda items, with a second by Councilmember Jasmine McDowell, and a vote of 6/0 for approval.

## V. Items to Consider

1. Consider, discuss, and take possible action approving the Quarterly City Investment Report for period ending December 31, 2024 (Enclosure).

City Manager Greg Hutson said that the interest rates on most of the investments are doing well. The rates have gone down, but are still doing well.

Councilmember Marty Jordan made a motion to approve the Quarterly City Investment Report for period ending December 31, 2024, with a second by Councilmember Jerry Webb, and a vote of 6/0 for approval.

2. Consider, discuss, and take possible action approving the Gilmer Police Department Racial Profiling Report for 2024, and all matters related thereto (Enclosure).

Police Chief Lana Davidson stated the state accepted the report as submitted with no issues.

Councilmember Marty Jordan made a motion to approve the Gilmer Police Department Racial Profiling Report for 2024, with a second by Councilmember Michael Chevalier, and a vote of 6/0 for approval.

3. Consider, discuss and take possible action approving and accepting the quote from C. Miller Drilling, Inc. for Water Well #5 Rehabilitation and increasing the depth of said Well by 80 feet, and all matters related thereto (Enclosure).

Jarom Tefteller entered the meeting at 5:25 P.M.

Cory Miller with C. Miller Drilling, Inc. addressed the council regarding the quote he submitted for the work on Well #5. He stated his group inspected the "down hole" video log of the well and the casing is still in good shape for its age. The water in the well has more hardness than

most and starts a chemical reaction (calcium incrustation) with the screen and ends up closing the screen over time reducing the productivity of the well. An acid wash of the incrustation needs to be performed, the dissolved slurry would be pumped out of the tank then neutralized to TCEQ standards for disposal. They would then install the pump back into the well at 80 feet deeper than before to improve the draw of the well. The process would take 3-4 days to complete once chemicals are ordered.

Mayor Pro-Tem Pete Herrmann made a motion to approve the quote from C. Miller Drilling, Inc. for Water Well #5 Rehabilitation and increasing the depth of said Well by 80 feet, with a second by Councilmember Michael Chevalier, and a vote of 7/0 for approval.

4. Consider, discuss, and take possible action to approve Resolution 25-003 regarding the Risk it for Brisket event street closure from April 4 at 8:00 pm until Sunday, April 6, 2025 at 8:00 pm for the event on April 5-6, 2025, and all matters related thereto (Enclosure).
