The City of Gilmer Council Special Meeting convened in special session at 5:15 P.M. on Tuesday, August 5, 2025, at Gilmer City Hall, 110 Buffalo St., Gilmer, Texas.

I. Call to Order
Invocation
Pledge of Allegiance

Mayor Tim Marshall called the meeting to order at 5:18 P.M. The invocation was led by Mayor Pro-Tem Pete Herrmann, and the Pledge of Allegiance was led by Councilmember Brian Williams.

II. Items to Consider

1. Consider, discuss, and take possible action to authorize Luana Howell, Upshur County Tax Assessor, as the designated officer of the city's taxing unit, and all matters related thereto.

Mayor Pro-Tem Pete Herrmann made a motion to authorize Luana Howell, Upshur County Tax Assessor, as the designated officer of the city's taxing unit, with a second by Councilmember Jerry Webb and a vote of 6/0 for approval.

- 2. Consider, discuss, and take possible action regarding Property Tax Rate for Fiscal Year 2025-2026, and all matters related thereto (Enclosure).
 - a. Discuss proposed tax rate for 2025-2026.
 - b. Take Record Vote on proposed tax rate for 2025-2026.
 - c. Vote to schedule public hearing on proposed tax rate for 2025-2026.

The council discussed each tax rate with the De Minimis Tax Rate being the proposed tax rate.

The City Council voted unanimously to schedule a public hearing on the proposed tax rate for 2025-2026 on August 25, 2025, at 5:15 P.M., with a 6/0 vote for approval.

3. Consider, discuss, and take possible action to approve Ordinance 25-048 amending the City Budget for the City of Gilmer, Texas for the one-year period beginning October 1, 2024, and ending September 30, 2025, for the payroll increase of an additional employee to public works in the amount of \$7,116.00, and all matters related thereto (Enclosure).

City Secretary Mary Bullock explained the proposed Budget Amendment was to bring back a former employee and the costs are for his payroll and benefits through September 30, 2025.

Mayor Pro-Tem Pete Herrmann made a motion to approve Ordinance 25-048 amending the City Budget for the City of Gilmer, Texas for the one-year period beginning October 1, 2024, and ending September 30, 2025, with a second by Councilmember Jerry Webb and a vote of 6/0 for approval.
