- 1. Mayor's Announcements: The poles are going up at Abney Park for the shades and a building is being erected at the soccer complex at Yamboree Park.
- 2. City Manager's Announcements: The next Parks Advisory Board Meeting will be at City Hall on November 18, 2025, at 5:30 P.M. in City Hall. Water Tank Project when they drained the second tank at the Harrison Street location, the contractors found additional structural issues that need addressed. They are putting together a list, and we will be seeing some change orders coming through for additional repairs.

Councilmember Jarom Tefteller made a motion to approve the City Investment Report for period ending September 30, 2025, with a second by Councilmember Jerry Webb and a vote of 7/0 for approval.

2. Tabled item from October 28, 2025, meeting to consider, discuss, and take possible action on approving the closure of Davis Street for the Christmas Boutique Crawl hosted by Leah Burris with O & P Collective on Monday, December 15, 2025, from 2:00 P.M. – 8:00 P.M., and matters related thereto (Enclosure).

The group from the Christmas Boutique Crawl addressed council regarding the event and stated they had checked with each of the business owners impacted by the street closure for approval. Public Works had asked for the street to be closed earlier in the day (7:00 A.M.) to avoid cars entering the area.

Councilmember Jarom Tefteller made a motion to approve the closure of Davis Street for the Christmas Boutique Crawl on Monday, December 15, 2025, from 7:00 A.M. – 8:00 P.M., with a second by Councilmember Jasmine McDowell and a vote of 7/0 for approval.

3. Consider, discuss, and take possible action regarding the change order request and recommendation from the Parks Advisory Board for approval in the amount of \$291,377.00, and all matters related thereto (Enclosure).

City Manager Mary Bullock discussed the change orders recommended by the Parks Advisory Board with the city council.

Councilmember Jarom Tefteller made a motion to approve the change order request from the Parks Advisory Board in the amount of \$291,377.00, with a second by Mayor Tim Marshall and a vote of 7/0 for approval.

4. Consider, discuss, and take possible action to approve Resolution R25-008 casting votes for a Two-Year term position(s) of the Upshur County Appraisal District Board of Directors, and all matters related thereto (Enclosure).

Councilmember Jarom Tefteller made a motion to approve Resolution R25-008 casting equal votes for the six nominees to a Two-Year term position(s) of the Upshur County Appraisal District Board of Directors, with a second by Councilmember Brian Williams and a vote of 7/0 for approval.

5. Consider, discuss, and take possible action to pass by Ordinance 25-059 to add no parking or stopping on Bruce Street from 7:00 A.M. - 9:00 A.M. and 3:00 P.M. - 5:00 P.M. to improve traffic flow during student drop-off and pick-up, and all matters related thereto (Enclosure).

Council discussed concerns regarding the street change and the impact it would have forcing traffic onto US Highway 271 S and State Highway 300. Councilmember Jarom Tefteller recommended the city work with Gilmer ISD to find additional options for traffic flow issues and Councilmember Jerry Webb stated he wanted the city to get the word out regarding the changes and to issue warnings before tickets with fines, so the community has time to adapt.

Mayor Pro-tem Pete Herrmann made a motion to pass by Ordinance 25-059 to add no parking or stopping on Bruce Street from 7:00 A.M. - 9:00 A.M. and 3:00 P.M. - 5:00 P.M. to improve traffic flow during student drop-off and pick-up, with a second by Councilmember Brian Williams and a vote of 7/0 for approval.

6. Consider, discuss, and take possible action to accept the grant from the Texas Forrest Service to the Volunteer Fire Department in the amount up to \$45,000 for a Slip-on Skid Unit, and matters related thereto (Enclosure).
