APPROVING PROPOSED CHARTER AMENDMENTS

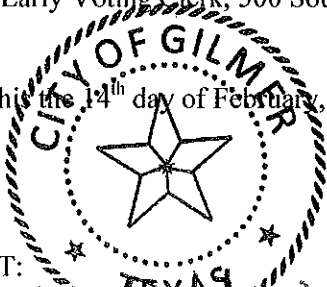
